# 2017 Australian Rallycross Series – Round 6 Event Regulations

## Jurisdiction:

Round 6 of the 2017 Australian Rallycross Series will be held in accordance with the RXA Series Regulations, the RACERS Event Operating Manual & these Event Regulations.

## 1. Meeting format – each class

1 x 10-minute Practice session – If fields are over-subscribed, competitors will be split into smaller groups to give everyone track room and track time. Each Competitor's fastest practice lap (excluding any Joker laps) will be used to split each class into Groups (A, B & C) for qualifying.

1 x 10-minute Qualifying session per Group (A, B & C) – each Competitor's fastest lap (excluding any Joker laps) will be used to set the grids for Heat races. Heat grids will be set as follows: Heat 1 – fastest lap on pole, 2<sup>nd</sup> fastest lap 2<sup>nd</sup> & so on; Heat 2 – reverse grid; Heat 3 – top 4 only reversed.

Where any class has more than 8 competitors, there will be several 8-car Groups (A, B & C) each competing in 3 heats.

3 x 4 lap Heat races – each competitor's best 2 overall heat times will be averaged and used to set the grid for the Final of that Group – lowest time on pole, 2<sup>nd</sup> lowest in P2 & so on.

1 x 6 lap Final for each Group (A, B & C)

1 x 6 lap Super Final for each class gridded from:

- 1<sup>st</sup> four (4) placegetters from Group A Final
- then 1<sup>st</sup> two (2) placegetters from Group B Final
- then 1<sup>st</sup> two (2) placegetters from Group C Final (if no Group C needed, these 2 places to be gridded from 3<sup>rd</sup> & 4<sup>th</sup> placegetters from Group B Final)

\* RXA may combine classes on track depending on entries but points and awards will be made on a class-by-class basis.

## 2. RXA Series Points

Each class Heats, Final and Super Final will be allocated points towards the overall RXA Series. Current RXA Series points will be posted on the RXA website.

Series Points will be awarded at this meeting as follows for each class:

## 3. Trophies

Trophies will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> in the Super Final for each class and the results posted on the RXA web site and Facebook page.

### 5. Licence, Entry & sign on Requirements

- 5.1 All competitors must hold a RACERS National Licence (link to application on RXA website – [www.rxaus.com.au](http://www.rxaus.com.au)) and present this licence at sign on.
- 5.2 Competitors who hold a current CAMS licence need only a RACERS Clubman licence and present both at sign on. RACERS recognise the 2 licences together at the same level as their National Licence.
- 5.3 Observed Licence Tests for Competitors needing them will be conducted during Practice sessions.
- 5.4 **Licence documentation must be completed prior to the event unless by prior arrangement with RXA.**
- 5.5 Entries can be made online on the RXA website ([www.rxaus.com.au](http://www.rxaus.com.au)). Entry fee is \$250. Whilst entries on the day can be accepted, processing those entries may cause delays to the program and entering prior to the event will assist in everyone's enjoyment.
- 5.6 Competitors & team members will be required to sign on including an indemnity before they can compete at this event at the designated area in the pit area.
- 5.7 Collection of Competitor wristbands will take place at sign on. Each Competitor will need to show a wristband to take part in practice and racing.
- 5.8 To enable smooth running of the event, Competitors should proceed to sign on as soon as they arrive at the venue.

### 6. Vehicle Types and Scrutineering

- 6.1 Vehicles must comply with the Technical Series Regulations located on the RXA website ([www.rxaus.com.au](http://www.rxaus.com.au)).
- 6.2 Each Competitor must complete a RACERS Car & Equipment Checklist and present it at sign on. The checklist is included in these regulations.
- 6.3 The Event Scrutineer may conduct spot checks at any time.
- 6.4 Excel Class competitors are not permitted to carry or use radio communications equipment.

### 7. Timing

Timing is by Tampered Motorsport. Each Competitor will be supplied with a transponder that must be fitted using lock ties in a location advised by the Timekeeper. Damage to transponders may incur a cost to the Competitor.

### 8. Drivers' briefing

All drivers MUST attend the drivers' briefing held at the Sign on building at 9:30 AM – there are specific instructions (such as start procedure) that all Drivers need to be briefed on.

### 9. Driver's Apparel

- 9.1 Helmets must comply with or exceed AS1698, SFI 41.1 or the equivalent SFI or FIA Standards.
- 9.2 A HANS or FHR device compliant with SFI 38.1 is MANDATORY.
- 9.3 Full face helmets must be worn in open cars
- 9.4 Drivers must wear one piece overalls that meet the requirements of SFI 3.2A or SFI 40.1.

- 9.5 Boots, socks, shoes, balaclavas and gloves must be made of Nomex or a similar flame protecting material complying with SFI 3.3 or FIA equivalents

### 10. Specific Circuit Requirements

- 10.1 Track Density for racing is 10, for practice 20
- 10.2 Noise Control
- 10.2.1 Motor racing may only occur between 10.00 AM and 5.00 PM on race days, with allowance for an extension to 6.00 PM in the event of serious mishap, inclement weather or other exceptional circumstances. There must be no vehicles on track at any other time.
- 10.2.2 Motor racing vehicles may be operated in the pit area only for the purpose of:
- 10.2.2.1 Unloading and scrutineering from 8.30 AM on race days, provided that motor racing vehicle engines are started only as necessary and noise is kept as low as practically possible;
- 10.2.2.2 Off track testing or tuning, from 9.00 AM on race days and
- 10.2.2.3 Loading, until 6.00 PM on race days, or if there is an extension to the motor racing hours in accordance with regulation 10.2.1 7.00 PM provided that motor racing vehicle engines are started only as necessary and noise is kept as low as practically possible.
- 10.2.3 The noise level of each motor racing vehicle will be measured and recorded in a log book. The trackside limit (measured 10 metres from the track edge at the noise recording position) is 106dB(A)<sub>L</sub>max,T.
- 10.2.4 Any motor racing vehicle exceeding the noise limit will be removed from track until modifications are made to the vehicle so that it complies with the noise limit.
- 10.2.5 The public address system may only be used between 9.00 AM & 10.00 AM for calling competitors to briefings and otherwise between 10.00 AM and 5.00PM on race days or until 6.00 PM if regulation 10.2.1 applies.
- 10.3 On site camping is not permitted for this event.

### 11. Numbers & Signage

- 11.1 All cars must have competition numbers on the rear side window's 200mm high and PMS 804 in color. (Fluoro orange).
- 11.2 The driver's surname will be placed above the competition number in a non-conflicting color, lettering 100mm high.
- 11.3 All cars must have a competition number on the front passenger side 100mm high and PMS 804 in color (fluoro orange)
- 11.4 All cars must have a competition number in the lower middle rear window 100mm high and PMS 804 in color (fluoro orange)
- 11.5 RXA reserves the right to the top 150mm of the front windscreen for series sponsorship.
- 11.6 RXA may assign competition numbers.
